SUMMARY—Revises provisions governing the program for the operation of vending facilities by licensees who are blind. (BDR 38-320)

AN ACT relating to persons with disabilities; providing for the training of licensees under the program for the operation of vending facilities by licensees who are blind; establishing procedures for the resolution of certain disputes related to the program; revising certain terminology related to the program; revising provisions establishing a priority of right for the operation by licensees of vending facilities in or on certain public buildings and properties; authorizing the operation of vending facilities by licensees in or on the buildings and properties of certain agencies; providing for the election of the Nevada Committee of Vendors Who Are Blind and prescribing certain duties of the Committee; authorizing contracts under which a licensee operates a vending facility on certain private property to provide for the payment of an incentive to the owner of the property; making certain other revisions relating to the operation of the program; **adding exceptions to criminal provisions governing certain unauthorized sales, solicitations of orders and deliveries in or on public buildings or property**; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law creates a program to establish vending stands on public property to be
2 operated by persons who are blind. (NRS 426.630-426.720) **Sections 5-19** of this bill revise
3 certain terminology, including: (1) substituting the term “vending facility” for “vending
4 stand”; (2) using the term “licensee” to describe a person who is blind and who is licensed by
5 the Bureau of Services to Persons Who Are Blind or Visually Impaired in the Department of
6 Employment, Training and Rehabilitation to operate a vending facility; and (3) using the
7 standard term ~~“department or agency”~~ **“public entity** that has care, custody and control of a

8 public building or property” to refer to the governmental agency in charge of a public building
9 or property. **Section 2** of this bill requires the Bureau to provide certain training and assistance
10 for licensees and persons who wish to become licensees.

11 Existing law: (1) defines the term “public building” or “property” to mean any building,
12 land or real property owned, leased or occupied by a department or agency of the State or its
13 political subdivisions, except for public elementary and secondary schools, the Nevada
14 System of Higher Education, the Nevada State Park System and the Department of
15 Corrections; and (2) provides that licensees have priority of right to operate vending stands in
16 or on any such public buildings or properties with suitable locations for a vending stand. (NRS
17 426.630, 426.640) **Section 6 of this bill expands the definition to include an airport
18 authority operating in this State and a department of aviation which is operated by a
19 political subdivision of this State, excluding certain building, land or other real property
20 that is leased or operated for the purposes of live entertainment.** **Section 7** of this bill
21 grants the Bureau the right of first refusal, on behalf of licensees, with regard to the operation
22 of a vending facility in or on a public building or property. **Section 11** of this bill: (1) removes
23 authorization for the Bureau to establish a vending facility in or on a public building or
24 property with the consent of the head of a department or agency responsible for the
25 maintenance of a public building or property; and (2) **if the Bureau has determined that the
26 public building or property is a suitable site for a vending facility,** instead requires the
27 ~~{department or agency}~~ **public entity** having care, custody and control of a public building or
28 property to cooperate with the Bureau to **discuss options for a vending facility and, upon
29 reaching agreement, cooperate to** establish a vending facility. ~~{if the Bureau has determined
30 that the public building or property is a suitable site for a vending facility.}~~ **Section 3** of this
31 bill provides for the resolution of a dispute between the Bureau and a ~~{department or agency}~~
32 **public entity** that has care, custody and control of a public building or property by the
33 Hearings Division of the Department of Administration. **Section 24** of this bill makes a
34 conforming change to remove a provision establishing procedures for resolving a dispute
35 when a department or agency rejects establishment of a vending facility.

36 **Section 7** authorizes the operation of vending facilities by licensees in or on buildings or
37 properties of **an airport authority or department of aviation, under certain conditions,** the
38 Nevada System of Higher Education, the Nevada State Park System and the Department of
39 Corrections with the approval of the Bureau and the applicable state agency.

40 Existing law requires a state or local department or agency to notify the Bureau at least 30
41 days before reactivation, leasing, releasing, licensing or issuing a permit for the operation of a
42 vending facility in or on a public building or property. (NRS 426.650) **Section 8** of this bill:
43 (1) moves back the deadline for such notification to at least ~~{90}~~ **60** days before the planned
44 action; and (2) additionally requires a state or ~~{local department or agency}~~ **public entity** to
45 notify the Bureau at least ~~{90}~~ **60** days before requesting proposals for, or occupying, a
46 vending facility in or on a public building or property. **Section 9** of this bill removes a
47 requirement for annual notification of the Bureau concerning new construction, remodeling,
48 leasing, acquisition or improvement of public buildings or properties at certain airports and
49 instead requires notice to be provided within 30 days after the commencement of planning and
50 design of the project, as is required by existing law for such a project on any other public
51 building or property. (NRS 426.660)

52 Existing federal regulations: (1) require the state agency in charge of licensing blind
53 vendors to provide for the biennial election of a State Committee of Blind Vendors; and (2)
54 prescribe the duties of the Committee. (34 C.F.R. § 395.14) Existing regulations create the
55 Nevada Committee of Vendors Who Are Blind. (NAC 426.080) **Section 11** requires the
56 Bureau to provide for the election of the Nevada Committee of Vendors Who Are Blind and
57 provides for the active participation of the Committee in administrative decisions concerning
58 the Vending Facility Program.

59 **Section 11** also authorizes the Bureau to: (1) adopt certain regulations relating to the
60 operation of the Vending Facility Program; and (2) enter into certain contracts relating to the
61 operation of vending facilities. ~~{Section 11 authorizes a licensee, with the approval of the
62 Bureau, to utilize a third-party vendor to carry out any responsibilities relating to the operation
63 of a vending facility.}~~ **Section 12** of this bill authorizes the Bureau to use certain money it
64 receives pursuant to the Vending Facility Program for services related to the management of
65 the Program.

66 Existing law: (1) authorizes the Bureau to establish a checking account for the interim
 67 operation of a vending facility if the licensee who operates the facility is unavailable; and (2)
 68 requires the Bureau to close such an account and make a check payable to the licensee for the
 69 remaining balance of the account if the licensee returns after a temporary disability. (NRS
 70 426.677) **Section 13** of this bill requires the Bureau to make a check payable to the licensee
 71 for the remaining balance of the account if the licensee is unable to return to operating the
 72 vending facility within 6 months after becoming unable to work.

73 Existing law authorizes the Bureau to establish a vending facility on private property if
 74 the property owner consents and enters into a contract with the Bureau. (NRS 428.685)
 75 **Section 14** of this bill authorizes the Bureau to enter into such a contract pursuant to which
 76 the licensee may pay an incentive to the property owner for certain locations. **Section 18** of
 77 this bill: (1) authorizes the Bureau, after actively consulting with the Committee of Vendors
 78 Who Are Blind, to utilize a nonprofit organization to manage any portion of the operations of
 79 the Vending Facility Program; and (2) requires any such arrangement to comply with certain
 80 federal regulations. Section 19 of this bill adds further exceptions from the existing
 81 criminal penalties for certain sales, solicitations of orders for or deliveries of
 82 commodities authorized for sale in or on any public building or property.

83 Sections 8 and 24 of this bill eliminate certain obsolete provisions.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
 SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 426 of NRS is hereby amended by adding thereto the
 2 provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2.** *1. The Bureau shall establish a training program for persons who
 4 wish to become licensees. The training must include, without limitation, a
 5 standard curriculum and on-the-job training while working for a vending facility.*

6 *2. The Bureau may designate not more than two vending facilities as
 7 training sites to be operated by the Bureau or a third-party vendor.*

8 *3. The Bureau may waive any training required pursuant to this section for
 9 a person who is blind and is otherwise qualified to operate a vending facility.*

10 *4. The Bureau shall:*

11 *(a) Provide licensees with upward mobility training; and*

12 *(b) Assist the Nevada Committee of Vendors Who Are Blind in sponsoring
 13 meetings and training conferences for licensees.*

14 **Sec. 3.** *1. Except as otherwise provided in subsection 2, if a dispute arises
 15 between a ~~(department or agency)~~ public entity that has care, custody and control
 16 of a public building or property and the Bureau concerning any matter related to
 17 the Vending Facility Program, either party may file a complaint describing the
 18 dispute with the Hearings Division of the Department of Administration.*

19 *2. The Hearings Division may not:*

20 *(a) Hear a complaint concerning the status of a licensee or third-party
 21 vendor operating a vending facility under an agreement with the Bureau; or*

22 *(b) Award damages as a result of a hearing on a complaint filed pursuant to
 23 this section.*

24 *3. Not later than 30 days after a complaint is filed pursuant to subsection 1:*

25 *(a) The Hearings Division shall appoint a hearing officer; and*

26 *(b) The hearing officer shall set a date for a hearing.*

27 *4. Except as otherwise provided in this section, a hearing must be
 28 conducted in accordance with NRS 233B.121 to 233B.150, inclusive. The hearing
 29 officer may issue a ruling based on the briefs submitted by the parties without
 30 hearing additional evidence.*

1 5. A decision of the hearing officer made pursuant to this section is a final
 2 decision for purposes of judicial review, ~~it~~ and may be appealed to the district
 3 court pursuant to the provisions of chapter 233B of NRS. Any such appeal must
 4 be filed not later than 30 days after the date of service of the final decision of the
 5 hearing officer.

6 **Sec. 4.** NRS 426.563 is hereby amended to read as follows:

7 426.563 Costs of administration of NRS 426.517 to ~~[426.720,]~~ **426.715,**
 8 inclusive, **and sections 2 and 3 of this act** shall be paid out on claims presented by
 9 the Bureau in the same manner as other claims against the State are paid.

10 **Sec. 5.** NRS 426.590 is hereby amended to read as follows:

11 426.590 The Bureau is hereby designated as the licensing agency for the
 12 purposes of 20 U.S.C. §§ 107a to 107f, inclusive, and acts amendatory thereto, and
 13 the Bureau is authorized to comply with such requirements as may be necessary to
 14 qualify for federal approval and achieve maximum federal participation in the
 15 Vending ~~[Stand]~~ **Facility** Program **established by NRS 426.630 to 426.715,**
 16 **inclusive, and sections 2 and 3 of this act** under such federal statutes.

17 **Sec. 6.** NRS 426.630 is hereby amended to read as follows:

18 426.630 As used in NRS 426.630 to ~~[426.720,]~~ **426.715,** inclusive, **and**
 19 **sections 2 and 3 of this act,** unless the context otherwise requires:

20 1. ~~["Operator"]~~ **"Licensee"** means ~~[the individual]~~ **a** person who is blind **and**
 21 **who is licensed by the Bureau to operate a vending facility in or on a public**
 22 **building or property or on federal property.**

23 2. **"Nevada Committee of Vendors Who Are Blind"** means **the Committee of**
 24 **Vendors Who Are Blind elected pursuant to NRS 426.670 and 34 C.F.R. §**
 25 **395.14.**

 28 **resale, hiring employees and performing other duties associated with managing a**
 29 **vending facility.**

 32 any building, land or other real property, owned, leased or occupied by any ~~[department~~

 34 public elementary and secondary schools, the Nevada System of Higher Education,
 35 the Nevada State Park System, ~~[and] the Department of Corrections ~~[~~~~

38 (b) Does not include any building, land or other real property that is:

42 5. "Public entity" means any department, agency or political subdivision of
 43 the State, any department or agency of a political subdivision of the State or any
 44 public or quasi-public corporation that is supported in whole or in part by public
 45 money. The term includes, without limitation, a regional transportation
 46 commission, an irrigation district or water district created under the laws of the
 47 State of Nevada, and all boards, commissions and committees created by a public
 48 entity or the Legislature.

49 6. **"Vending ~~[stand]" facility"~~** means ~~[~~

50 ~~— (a) Such buildings, shelters, counters, shelving, display and wall cases,~~
 51 ~~refrigerating apparatus and other appropriate auxiliary equipment as are necessary~~
 52 ~~or customarily used for the vending of such articles or the provision of such~~
 53 ~~services as may be approved by the Bureau and the department or agency having~~

1 care, custody and control of the building or property in or on which the vending

27 *2 and 3 of this act* by the Bureau:

If, after a vending stand survey as authorized by NRS 426.670, the head of a department or agency in charge of the maintenance of any public building or property rejects or does not act upon a written recommendation of the Bureau that a vending stand be established or operated for the employment of persons who are blind, the matter must be referred to the Director of the Department of Employment, Training and Rehabilitation for review.

2. After reviewing the recommendation of the Bureau, the Director may refer the matter to the head of the department or agency concerned for further review and disposition.

3. If the Director is not satisfied with the decision of the head of the department or agency concerned, the Director may refer the matter for final decision and disposition to:

(a) The Governor, in the case of state buildings or properties.

(b) The board of county commissioners, in the case of county buildings or properties.

(c) The city council or other governing board of the municipality in the case of municipal buildings or properties.

(d) The governing board of the political subdivision in the case of buildings or properties of other political subdivisions of this State.

426.720 Applicability of provisions to operators of vending stands.

1. Persons operating vending stands in public buildings or on public properties as defined in NRS 426.630 prior to March 13, 1959, shall not be affected by the provisions of NRS 426.630 to 426.720, inclusive, except and only insofar as provided by subsection 2 of NRS 426.650.

2. Any person who is blind who is presently operating a vending stand in or on public buildings or properties who desires to avail himself or herself of the advantages of the Program authorized by NRS 426.630 to 426.720, inclusive, shall have the right to do so, and in such instance, the Bureau may negotiate and consummate arrangements for the purchase of such vending stand equipment as it may deem necessary for the satisfactory operation of the vending stand.
